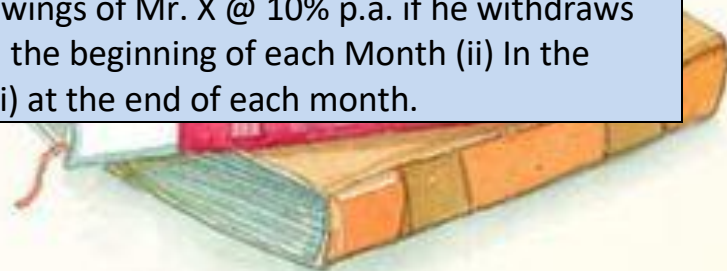

- A, B and C share profits in the ratio 3:2:1 respectively. C wants that profits be shared equally and it should be applicable retrospectively from the last three years. Other partners have no objection to this. Profits for the last three years were Rs 1,20,000, Rs 94,000 and Rs 1,10,000 respectively. Record adjustment that means a journal entry and showing the working notes.

- L, M, and N were partners in firm sharing profit in the ratio of 3 : 4 : 5. Their fixed capitals were L Rs 4,00,000 , M Rs 5,00,000 and N Rs 6,00,000 respectively. The partnership deed provided for the following:

1. Interest on capital @ 6% p.a.

2. Salary of Rs 30,000 p.a. to N.

3. Interest on partner's drawings will be charged @ 12% p.a.

4. During the year ended 31.3.2009, the firm earned a profit of Rs 2,70,000. L withdrew Rs 10,000 on 1.4.2008. M withdrew Rs 12,000 on 30.09.2008. and N withdrew Rs 15,000 on 31.12.2008. Prepare profit and loss appropriation account for the year ended 31.3.2009.

- P,Q and R are partners sharing profits in the ratio of 3 : 2 : 1. However, R is guaranteed Rs. 20,000 as his share of profits every year. Deficiency if any would be borne by the other partners. The profits for the two years ending 31st March, 2008 and 31st March, 2009 had been Rs. 75,000 and Rs. 80,000 respectively. Show the profit and loss appropriation account for the two years.

- A, B and C were partners in a firm. On 1st April, 2008, their fixed capitals stood at Rs. 50,000, Rs. 25,000 and Rs. 25,000 respectively.

As per the provisions of the partnership deed

- I. B was entitled for a salary of Rs. 5,000 per annum.

- II. All the partners were entitled to interest on capital at 5% per annum.

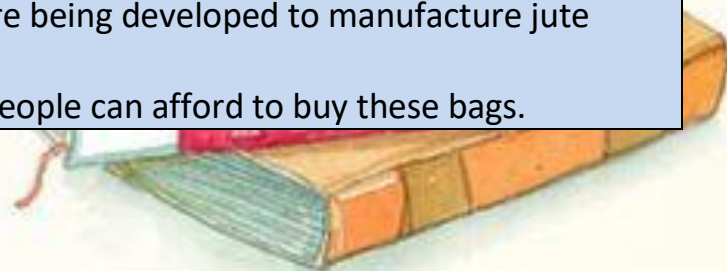
- III. Profits were to be shared in the ratio of capitals.

The net profit for the year ending 31st March, 2009 of Rs. 33,000 and 31st March, 2010 of Rs. 45,000 was divided equally without providing for the above terms. Pass an adjustment journal entry to rectify the above error.

- A business earned average profits of Rs. 1,00,000 during the last few years. The normal rate of return in a similar type of business is 10%. The assets of the business were Rs. 10,00,000 and external liabilities was Rs. 1,80,000. Calculate the value of goodwill of the firm by super profit method, if the goodwill is valued at 2. 1/2 years' purchase of super profits.

- State any two occasions on which a firm can be reconstituted.

Calculate the individual partner's gain or sacrifice due to the change in ratio. • X and Y are partners in a firm sharing profits in the ratio of 3:2. They decided to share future profits equally. On the date of change in the profit-sharing ratio, the Profit and Loss Account showed a debit balance of Rs 50,000. Pass the necessary Journal entry for the distribution of the balance in the Profit and Loss Account immediately before the change in the profit-sharing ratio. • Anant, Gulab and Khushbu were partners in a firm sharing profits in the ratio of 5 : 3 : 2.
